<u>Disability Proposition Project:</u>
 Our Time is Now, group working with multiple programs including
 Vermont Council on Rural Development Sarah is a representative for people with disabilities.

Many issues they are working on, the current project of interest is the Disability Proposition Project. The group is holding "listening" sessions to get the public's input on important issues on disabilities. Disability Rights Vermont held a session. Will bring all the information together.

Looking for people to help with writing, research, holding sessions. IF you can't attend be sure to register anyway so you can be in the loop.

- Our Time is Now: Many programs came together to research to get information around employment and disability. Report was done. Named is "Our Time is Now". Now a consultant has started marketing this program. Huge marketing splash!
 - People called looking into how they can hire people with disabilities.
 - Also developed a new concept paper. Place Creative, and hopefully will be implemented the same way as the first. Focus on students in school and adults. This is HireAbility's goal. Access to Education and Employment pathways. Getting people with disabilities to know that they can get good work as well.

 - a. Tim Bradshaw wants to come in January about transportationand SILC. This may be a good starting point.
 - b. The youth summer program has transportation as a HUGE barrier.
 - c. A quick survey sent to consumers on the barriers to transportation. We want to partner with the organization who does the surveys.
- 4. Keep an eye out for SSI Youth benefits being guaranteed for 5 years.
 - a. NICKEL project. Sarah is a member, will get us information, WIG as well.
 - b. VCDR Platform- members to review to see if there are issues that could fall with us. The 2023 priority list will come out in December.
 - c. Cari will send out last year's list.

Other Ideas:

Legislators.

We talked about inviting legislators. Use card Room event to target face time with some legislators. Try to get legislators to meet with us during that day. We could also go before some committees. Asher thinks we should invite the Bennington Reps to our meeting. Tim may be the chair. There will be a large turnaround in the legislature, it would be great to do some education for disability issues. Maybe in collaboration with someone else?

Will & Heather put together a video on disability etiquette which was presented to a Legislative subgroup. This may be worth resurrecting. Get in touch with Heather to get it, she's on disability right now. Emily & Diane will follow up.

Sharing stories may have more impact.
