  - Stories
  - On legislative Web Page, there are committee assistants that can be contacted for meets or go straight to the chair
  - Follow up after meetings
- Issues are decided on in the beginning of session. If concern is brought up after "Crossover" day, won't make it until the next session.
- The sessions run on a Biennium basis. We are at the beginning on one right now.
- An Accessibility Assessment is currently being done. After that, it would be a good time to approach.
- Sara Coffey is the chair of Transportation
- Social Equity Conference created a document, "Probing Questions".
   She will share with us to use as a prototype for us to create.
- Priorities right now, it looks like Housing is on the top of the list, childcare, looking back how money we got from ARPA & COVID is being used.
