1) Introductions (Marlena Hughes)

4) Vote: Chair (Marlena Hughes)

6) Presentation: Statewide Data on Disability and Employment in Vermont

(James Smith)

Discussion:

- Working age population data
 - Marlena asked what the requirements for supported employment are. James said that for VocRehab supported employment is not related to any diagnosis, but that the person needs intensive services that are ongoing to maintain employment. It is most commonly used for people with developmental disabilities who might have a job coach supporting them for months or years beyond initial placement.
 - Cornell University collects disability statistics from the US Census. The website makes it possible to run analytics and queries by groups, states, and other demographics. The latest data published is from 2017. It is all self-reported.
 - Marlena asked if there is support for people with disabilities in terms of language barriers and communication challenges to participate in the census. James said he is uncertain but will investigate.
- Demographic overview
 - James highlighted the data by age and pointed out that high school age and working age populations have a similar percentage of people with disabilities which he found surprising as one would expect the percentages to be lower in younger people.
 - Marlena highlighted that nearly half of Native American populations report having a disability. It was requested that more information and analysis be done here.
 - James shared that that data show that prevalence of working age adults with disabilities is 43k, though he suspects that this is an underestimate given that 33k people in VT are on SSDI benefits.
 - Employment rate for Vermonters with disabilities is 45.9% which has trended upward since 2013; James noted that there is a significant gap compared to the employment rate for people without disabilities.
 - Gina shared that the numbers make sense as people with disabilities may have supplemental income and/or their disability makes working full time difficult. She wondered if there was data broken down by part time employment.

- James shared that the extraordinary number of unemployment claims last month and this month due to COVID-19 will have a dramatic impact on trend data moving forward. However, he notes that VocRehab continues to have employers reaching out as they continue to hire.
- Marlana asked how VocRehab is preparing for the surge of applicants that will likely happen soon. James shared that they are preparing for this and have sent out letters to all consumers and former consumers informing them that they can help people who have been furloughed or who have lost their jobs.
- Marlana wondered about data for vocational certificates in addition to education. James shared that they don't have population data, but that VocRehab-along with VDOL- are collecting data on industry recognized credentials. James said that certification and apprenticeship programs are a priority.
- Marlana asked if these trends are seen in other states. James said these trends are national, but that the employment and post-secondary rates in Vermont are higher compared to other states.
- Specific disability populations
 - Marlana asked about people with psychiatric disabilities and the specialized programming VocRehab was investigating funding for. James shared that it is known that for people in this demographic employment helps to reduce symptoms and there is some data that shows that in the longer term it reduces hospitalization and the need for other services, but that funding continues to be a barrier to scaling up supportive employment services for people with psychiatric disabilities.
 - James shared that the numbers for people with psychiatric disabilities seems low and wonders if a lot of people are not connected with community mental health programs, surmising that they may be untreated, or treated through private practices. Gina echoed this and added that in her experience people with emotional or behavioral disabilities may not identify as having a disability and therefore may not be tapping into VocRehab services.
 - Marlana asked how many people with psychiatric disabilities are in the corrections systems as she worries that they are being underserved.
 - James and Marlana noted that employment of people with developmental disabilities is a success story in Vermont.
 - James noted that national statistics for employment rates of people with traumatic brain injuries are hard to come by, and suspects this is due to the lack of comprehensive service systems in place to serve this population. Marlana asked why this is, especially given the incidence in military populations. James shared that existing service systems in place for various populations have been created over decades, requiring high amounts of advocacy from individuals and families.
- Areas of known unmet need
 - Marlana asked how the data about unmet needs are considered when it comes to new programming. James shared that it is documented in

the needs assessment is done in order to inform the state plan. One of the state plan goals and priorities is to continue to provide supported employment for these populations in the upcoming years.

- Gina shared that, anecdotally in the Chittenden county jobs program, there is a growing number of people with disabilities who have a developmental disability but who are not eligible for developmental services and often have co-occurring mental health disorders. As such, the jobs program continues to be a place for people to refer 16-21 year olds and beyond but that it also creates a bottleneck.
- Daniele requested the breakdown of full time vs. part time employment for the next meeting.
