## Vermont Coalition for Disability Rights

### Legislature

The Legislature reconvened on Tuesday January 4<sup>th</sup> for the second year of the 2021-2022 Biennium.

The Legislature met remotely for the first two weeks of the session until the third week of January 17 when the House committees decided to meet in person with some members able to join remotely if they have health issues related to COVID.

House committees have been back in person, and they continue to livestream committee meetings. The House has continued to meet as a full body for floor activity, remotely, for now with remote access as well.

The Senate has been meeting remotely since the beginning of the session but is expected to be back after the town meeting break the second week of march. It is expected that both houses will begin to conduct floor activity in person at that time as well. Floor activity in the House and Senate will continue to be livestreamed.

Most activity at the Legislature will continue to be available remotely. This includes the respective caucuses, floor sessions of the House and Senate, legislative committees, and other proceedings. (*See links below*).

The Public and others can access the Statehouse, but everyone in the Statehouse lawmakers, staffers, lobbyists, media, and members of the public - will be required to wear at least a surgical mask.

The Legislature will meet on their regular (Tuesdays through Friday) schedule to do the session's work. House Appropriations generally meets on Mondays as well.

The work to combat the ongoing Coronavirus health and economic crisis continues to be a focus of the Legislature and the Scott Administration, in addition to continuing to make use of the federal ARPA monies and the new funds that will be coming to Vermont in the Federal Infrastructure bill now passed by Congress and signed into laws by the President. House and Senate Leaders will be tackling other key issues as well.

# S.210 An act relating to rental housing health and safety and affordable housing

The Senate passed this bill on Friday. The bill would create a statewide registry of rental units and would make the Dept of Public Safety responsible for rental investigations. It is a replacement bill for **S.79** that the Governor vetoed in 2020
