Legislature

The Legislature reconvened this Tuesday January 4th for the second year of the 2021-2022 Biennium.

Although the Legislative Rules Committee and other key leaders had every intent to meet "safely" in person this year beginning in January, they have decided to meet only remotely for the first two weeks this session because of the increased COVID threats and reassess at that time when more information following the end of year activities is available. The committee charged with overseeing the safe return to the Statehouse does have a plan for retuning in person.

When the Legislature does meet in person, as they expect to, they will continue to maintain remote access. Some committees have met in person at the Statehouse through the summer and fall. Although there have been some technology issues and other issues with meeting virtually, for the most part all legislative meetings can be accessed remotely. This includes the respective caucuses, floor sessions of the House and Senate, legislative committees, and other proceedings. (*See links below*)

The Legislature will meet on their regular (Tuesdays through Friday) schedule to do the session's work. House Appropriations generally meets on Mondays as well.

The work to combat the ongoing Coronavirus health and economic crisis continues to be a focus of the Legislature and the Scott Administration, in addition to continuing to make use of the federal ARPA monies and the new funds that will be coming to Vermont in the Federal Infrastructure bill now passed by Congress and signed into law by the President. House and Senate Leaders will be tackling tackling other key issues as well.
