# 6) Department for the Blind and Visually Impaired (DBVI) Grant

#### **Discussion:**

The team presented us information on the Vermont Pathways to Partnerships (VT-P2P) grant that they received.

Vermont has demonstrated commitments to school and community inclusion for children and youth with disabilities. Vermont also has a

strong track record for innovation in transition, employment, and postsecondary services and systems. However, many children and youth with disabilities do not have adequate transition plans, cannot access all supports, and subsequently have lower rates of employment.

VT-P2P is proposed as a unique partnership to address these needs. Our partners have committed to a common vision that *Vermont will build a culture of high expectations for youth with disabilities who are transitioning from high school to adult life.* This partnership will change context of transition by bringing statewide and local leaders together to lead high expectations and streamline effort to improve outcomes for youth. VT-P2P partners will improve the outcomes of indicators 13, 14 and the summary of performance for all students with disabilities.

VT-P2P will place youth with disabilities at the center, position project staff as facilitators and establish schools and community non-profits as hubs of transition service innovation to reach the following goals:

- 1. Establish Partnerships and High Performing System of Support. VT P2P will form interagency partnerships across an array of stakeholders to establish a comprehensive set of systems and strategies to achieve postsecondary success for youth with disabilities.
- 2. Center Leadership, Advocacy, and Engagement of People with Disabilities and Their Families. Students will be prepared as self-advocates and serve as primary contributors and decision-makers regarding their transition plans and services.
- 3. Improve Career and Post-secondary Outcomes for Youth with Disabilities. VT-P2P will improve employment, community participation and post-secondary education outcomes for youth with disabilities.

On January 4, 2024, the DBVI team met with the SRC to outline project goals and identify ways to keep informed moving forward. The project is in Year 1, the planning year. Year 2 will be the pilot year, with a projected scale up each year so that 80-100% of Vermont districts are accessing resources and innovative products funded by this project in Year 5.

The VT-P2P will pioneer a communication system that includes resource mapping in 12 regions of the state and the development of a web portal with information, multi-media on best practices in transition and supporting young adults with disabilities; further, youth, families, school teams, service providers, and community partners will access technical assistance.

A powerful innovation of VT-P2P is the shared community organization and involvement of leaders within the disability rights and independent living movement as partners with state entities and community non-profits, including organizations funded by the Administration for Community Living. This is novel for Vermont, a state divided geographically by mountain terrains and inconsistent access to technology. With a mission to ensure access, equity, and opportunity regardless of zip code, VT-P2P will increase workforce development, self-advocacy skills and peer learning opportunities through youth-centered activities geared toward postsecondary success.
