- 1. Address Policy Issues
- 2. Make sure individuals with lived experience are at the table.
- 3. Watch dogging & Advocacy work.
- Director reports to Council.
- Kirsten, director, is also the director of the Board at the National Level.
- Susan Shared Policy information
 - Every legislative session we try to connect council members with their legislators.
 - Weekly policy newsletter called "Policy Matters". Can send out to SRC members who are interested.
 - "Make a Date". Council members, people with lived disabilities and family members. Every day is disability awareness day. Teach all about legislation, committees, etc and areas of interest. Meet their own legislators and senators at the state house. Make state house a less scary place.
- Platform, What are the 2-5 top things we'll be laser focused on this session? 2024:
 - Housing Justice
 - We are Being included in all new housing programs
 - Home improvement program.
 - \circ Medicaid and those with disabilities
 - Shift the balance. Money to communities and not institutions
 - Able Claw Back ended in VT.
- Next Monday 3 live locations, They will send flyer about this.

- 2 new advisory groups that Medicaid is going to require in each state:
 - The MAC and the BAC (Medicaid and Benefits, Advisory Committees) https://dvha.vermont.gov/advisoryboards/medicaid-and-exchange-advisory-committee
