6) Discussion: Advocacy Goals (Group)

Discussion:

Asher asked people to reference the AOE Committee retreat notes shared in the advance of the meeting listed below:

AOE Committee Notes from October 7, 2021 Annual SRC Retreat

What would you like the priorities of your committee to be in the year ahead?

- *New branding work, important for the committee to help advertise and promote with consumers, and handing materials out*
- *VFN is having an in person conference next year in Chittenden County and would like to promote and attend that gathering.*
- *We miss seeing people in person and it would be good to see people in person again. Would like to consider a hybrid model for meetings.*
- *Would like to address the red-tape of being a consumer of VR (for example in order to get a PASS plan one needs to prove all over again that they're too disabled to work), of Social Security, state programs, and other benefits. Navigating it all is a full-time job and people would get further if the systems were simplified and less overwhelming. AOE could join with other groups to attempt to collaborate on an advocacy plan to demand bureaucratic reform.*
- *To assist with the above, AOE could invite Betsy Choquette and James Smith to come to a meeting and provide a historic perspective/context and help us prioritize which aspects to work on first and we could work with our Congressional delegation. VR's benefits counselors are also a resource that could help.*
- *We want to ensure that VR stays within DAIL.*
- *AOE wants to focus on opportunities for advocacy and outreach efforts in communities and around the state and re-align with the mission statement: How can we be more active and engaged? We want to help*

more and not exactly sure how to do this. We want to focus on a structural piece of this, create plans and execute plans.

- We would like a closer relationship with VCDR and move things on that platform that are important to this committee.*
- Create an update of our Legislative priorities for the year*
- Continue to host a card room event at the state legislature*
- Support the roll out and promotion of "Our Time is Now".*

What are the goals and action steps to get there, and what should our roles be?

- Connect more with VCDR and tie into their work.*
- Focus on a vision of a changed world- we need a vision of what that world will be and work backwards to meet that. Our group can have immense power to benefit VR consumers and removing barriers.*
- Use the rebranded material to educate the general public about VR issues and to advocate to the legislature.*
- We want to follow how elected officials are voting on pieces of legislation.*
- Getting the word out that VR even exists and making connections in schools as many families are not familiar with VR.*
- Ensuring that we have at least one person at all VCDR meetings.*
- Cari and Courtney are interested in connecting to VCDR moving forward.*

Asher mentioned that last year the AOE drafted both a [statement of support for H.266](#) as well as a list of [legislative priorities](#) that were adopted by the SRC. Members mentioned that it would be useful to do something similar for the year ahead.

Sherrie said the P&P Committee spoke at length about transportation and wondered if there are overlapping areas that the AOE Committee wanted to partner on.

Cari shared that the committee talked about increasing the spending guidelines and providing for flexibility in areas such as purchase, repair, drivers education, and CRASH. Paratransit, fixed bus routes, and micro transit were also discussed.

Asher invited revisions to current statement of H.266 support by the end of next week. Sarah suggested that we include any VR data in the letter about the cost of services.

7) Presentation: Money Follows the Person (Lynne Cleveland Vitzthum)**Discussion:**

Lynne provided an overview of the [Money Follows the Person](#) demonstration grant, which is currently slated to end September 2025.

Diane added that paying for environmental assessments is much bigger than just environmental—it includes assistive technology assessments across the board and VR has unsuccessfully attempted to work through this with Medicaid over the years to get a billing code to cover assessment. Lynne added that it doesn't make sense that Medicaid will pay for the assistive technology (AT) itself, but not the cost of the assessment for which AT is needed.

Sherrie asked what the vision is for attendant services. In South Burlington there is a program that might be considered a model in terms of shared housing. Lynne shared that it's an ongoing discussion within DAIL and that, at the moment, several families have come forward to request different living situations.

Emily asked if it would be possible to learn more about how people with chronic illnesses who have Social Security income too high to qualify for Medicaid (and thus don't qualify for many services and supports) might be better served in the future. Lynne said that though this project doesn't focus on that population specifically, they will continue to look at

Diane shared that VR could provide a more thorough presentation on the VR side of this grant once they hire the new project manager.

Sherrie asked if Sarah could provide a presentation on the model in Japan.
