What is Personal Attendant Services?

Services that provide people with disabilities help with "activities of daily living" (ADL)

May include:

- Dressing
- Bathing
- Transferring
- Light Housekeeping
- Meal Prep

Or "Instrumental Activities of Daily Living" (IADL)

May include: use the phone, shop for groceries, meals, managing your medicines, house cleaning, money management/paying bills

Personal Attendants

People providing personal attendant services to individuals with disabilities. Could be family members (paid and volunteers), or a professional.

Independent Living Philosophy

- People with disabilities can direct their own services
- "Care" is not a preferred term, but "services and supports" instead
 - ▶ Example: Personal Attendant vs. Personal Care Attendant
 - Example: Personal Care Services vs. Supports and Services in the home
 - Paying for Personal Attendant Services should not impoverish the person with a disability and they should be able to earn and keep assets to become more financially independent (which is counter to Medicaid provided services)

VT Programs to highlight

- There are many programs that help support people in their homes- some through Home Health and Hospice, Area Agency on Aging offices and within the Dept of Disabilities, Aging and Independent Living. For example: Traumatic Brain Injury Program that helps folks with a TBI live in the community as opposed in residential settings.
- ► For today will highlight Choices for Care program, the Participant Directed Attendant Care Program and the Money Follows the Person Program

Participant Directed Attendant Services Program (PDAC)

- Survey of needs in the 1980s led to report produced by VT Center for Independent Living
- Creation of PDAC initially run through Division of Voc Rehab
- Funded by the General Fund (VT Legislature) Not Medicaid Dollars
- Allowed for more flexibility
 - Family member payments for services
 - No asset limits for eligibility allowing for financial independence and growth
 - People with disabilities direct their own services
 - PDAC program FROZEN since 2014

Choices for Care

- Medicaid Funded program
- Pays for In home services, Adult Family Home, Enhanced Residential Care and Nursing Homes
- Eligible: 65 years or older or 18 and above who has a physical disablity.
- CFC: Flexible Choices
 - ▶ Like PDAC pays for supports and services in the home
 - ► Flexible Choices allows for paid family support and individual to direct their own services
 - ▶ Difference: Asset limit of \$2,000 unlike PDAC

Future Projects- Money Follows the Person (new grant cycle)

- In 2011 DAIL received \$17.9 million from Center for Medicare and Medicaid Services (CMS)
- Projects to transition people out of nursing homes and into the community
- Various projects funded through this grant and individual transition dollars. Partnership with Aging and Disability Resource Connection (ADRC), creation of the Adult Family Home program, and others
- DAIL has applied for a new grant and has been awarded. More details to follow.
